Much of this data is drawn from the appendices of **Jim Snowdon's MA thesis "Footprints in the Marsh Mud"**...although it appears there in five separate listings.

- a Jim Snowdon provided indications of which colony various Planters came from, where known... in many cases he gives the town as well.
- b "Subscribers" were those whose names appear on a list identified as the "Providence Association" represented by Agents, who scouted out the situation for them and were in communication with the Gov & Council in Halifax. These names appear on the Oct 1759 Township of Sackville proclamation which grants them exclusive rights to a share (or 1.5 or 2) within the boundaries of the township. Only 33 of the 155 on the list seem to arrive. But, 10 family names are nevertheless represented by another name than on the subscriber list.
- c In 1762-63 the Committee authorized to lay out divisions of the township and oversee a "drawing" of numbered shares, carried out their work which was recorded in the Townbook minutes, a portion of which survive. These numbers/division are drawn from this source, and also from the petition submitted years later, in 1786, in which these early allocations were listed. These two sources do not always agree.
- d Jim Snowdon has recorded the size of allocations on two separate lists, drawing upon the above sources (and others?), combined here.
- e, f, g and h In each of these years, the Gov in Council, in Halifax, confirmed clear title -- "grants" -- to a portion of those in Sackville who claimed to have fulfilled the appropriate conditions. Jim Snowdon checked these grants against this list of names, as we have recaptured here.
- i Jim noted whether an allotment was never confirmed, was later escheated or relinquished, and noted the year of major land sales.
- j The information in this column is drawn from the petition of 1786, which for each Numbered Share, indicates who received that grant and then adds some indication of whether it was subsequently sold, to whom, or whether the original grantee remained on the premises. This source of information supplements, but does not always agree with, what is listed in the Town minutes (also used for column c).
- k, l and m In one of Jim's lists he marks whether a Planter's name has appeared on the census conducted in that year, each of which he checked.
- n and o Information in these two columns came from separate lists in Jim's thesis. Those in the "Eddy Rebellion" were usually gone by 1776.  
  
Jim also lists perhaps 40 cases of Sackville lands being purchased between 1770 and 1800 by New Englanders (not Yorkshiresmen nor Loyalist), many second generation from these same families, and some from Cumberland and elsewhere in old Nova Scotia.
